February 2011 Alternative Fuel Finder Table

NREL maintains a database of alternative fueling stations nationwide through the Alternative Fuels and Advanced Vehicles Data Center (AFDC). The table below shows one biodiesel station, one CNG station, 15 E85 stations, and 24 electric vehicle supply equipment (EVSE) stations added in 20 states since the January 2011 edition of Federal Fleet Files. Unless otherwise noted, only open, publicly accessible stations are included. Electric vehicle supply equipment stations are included to prepare agencies for incorporating electric vehicles into fleets.
